The same applies to posts that contain vulgar, abusive or hate speech, or posts that violate the rights of third parties.

Posts that spread disinformation will also not be tolerated.

Stay on Topic

Please ensure that your comments are relevant to the original post and avoid posting content that has little or nothing to do with it. We reserve the right to delete or report such posts.

Use of Quotations

To quote correctly, the right source must be provided. You must give a source or author that can be verified by other users.

Avoiding Spam

Posts that take the form of chain letters, junk mail or spam will be deleted. We also reserve the right to ban and/or report users who distribute such content.

Misuse of the World Health Summit social media sites to advertise websites or services or to sell goods or services, either commercially or privately, is not permitted. Such posts will be deleted or reported.

Do not post content, information or other material that violates any law.
